Freeholder Scanlon offered congratulations to Freeholders Estrada, Scutari and Stender. She also congratulated Chairman Sullivan and Vice Chairman Mirabella on their new positions.

Freeholder Estrada stated that it was a pleasure to be a part of the Board and that he was looking forward to working with everyone. He thanked everyone for their support.

Freeholder Scutari thanked Vincent Lehotsky for his kind words. He stated that it was a pleasure serving as Chairman last year, and that it was a great year. He said that just as many great things were accomplished last year, many would also be done this year.

Freeholder Stender thanked everyone for their support, and stated that she looked forward to working with everyone.

Vice Chairman Mirabella congratulated Freeholders Estrada, Scutari and Stender, and Surrogate Jim LaCorte. He stated that he appreciated everyone's confidence in electing him Vice Chairman.

The Vice Chairman also stated that he admired Freeholder Scutari's integrity, hard work and stick-to-itiveness during his Chairmanship. He then stated that he looked forward to working with Chairman Sullivan, and that the high productivity level that has become the norm for this Board would continue.

He also thanked the Clerk of the Board and her staff, expressing gratitude for their efforts in putting this meeting together. He also congratulated Freeholder Scutari on the success of his term as Chairman.
