

**UNION COUNTY BOARD OF CHOSEN FREEHOLDERS**

**MINUTES OF THE REGULAR MEETING**

**DECEMBER 8, 2005**

Chairman Rick Proctor presided. Roll call showed Vice Chairman Alexander Mirabella, Freeholder Angel G. Estrada, Freeholder Chester Holmes, Freeholder Bette Jane Kowalski, Freeholder Adrian O. Mapp, Freeholder Deborah P. Scanlon, Freeholder Daniel P. Sullivan, and Freeholder Nancy Ward in attendance.

Also in attendance were County Manager George W. Devanney, County Counsel Robert Barry and Clerk of the Board Nicole L. Tedeschi.

**PRAYER AND SALUTE TO THE FLAG** were led by the Clerk of the Board.

**OPEN PUBLIC MEETINGS ACT** was read by the Clerk of the Board.

The Chairman called for a motion to approve the minutes. On a motion by Vice Chairman Mirabella, seconded by Freeholder Holmes, roll call showed eight members of the Board voted in the affirmative on the minutes of November 9, 2005 for the Agenda, Regular and Executive Meetings, with Freeholder Mapp abstaining.

The Chairman called for a motion to approve the communications. On a motion by Vice Chairman Mirabella, seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

The Chairman called upon Vice Chairman Mirabella to join him in presenting resolutions to honored guests.

Chairman Proctor and Vice Chairman Mirabella called upon Ray Hechler, joined by Sal Mione from the office of Veterans Affairs. Mr. Hechler is a veteran of the USS Helena which was bombed during the attacks on Pearl Harbor and was presented with Resolution 1243-2005 recognizing Pearl Harbor Remembrance Day. Vice Chairman Mirabella thanked Mr. Hechler for his service so many years ago. He stated that his trip to Pearl Harbor was inspiring and that he had sincere gratitude toward Mr. Hechler and his fellow Veterans. Chairman Proctor also thanked Mr. Hechler for attending the meeting and for his commitment and service. Mr. Hechler

spoke about his experience as a Marine Veteran and his career in the military including the events of the attack on Pearl Harbor. He thanked the Board for the honor.

The Chairman called upon Warren Hehl, President of the Union County Public Health Association and Roberta Milano, Coordinator of Union County Links and along with Vice Chairman Mirabella presented them with Resolution 1244-2005 which thanks public health officers for their service.

Bruce Patterson, Garwood, suggested that the resolutions should note if there is money received from the state. He then inquired as to why the County is installing water utility service to the Deserted Village of Feltsville, Watchung Reservation. Freeholder Scanlon and Director Sigmund answered his question explaining that the water was necessary to install restrooms for visitors and to provide city water for the residents. Mr. Patterson inquired to the rent of the residents of the area and Chairman Proctor said that the project was not at that stage yet.
