The Monday after the events, the insurance company will look at the precipitation measurements for the Newark Airport. If there is more than .75 inches, then they will pay you the insured sum for that day. You don't need to file an actual "claim."

Rain insurance, and whether a claim will be paid, is not contingent on whether or not an event was cancelled. Your insuring against the chance that it may rain only. So, if it rains so much that lakes start to form, you can still be paid.

Does that clear it up a bit?
