**AN ORDINANCE FIXING THE SALARIES OF COUNTY OFFICIALS AND DEPARTMENT HEADS**

BE IT ORDAINED by the Board of Chosen Freeholders of the County of Union as follows:

Section 1. The salaries of the Freeholders, Chairman and Vice-Chairman shall be as hereinafter set forth.

Section 2. The salaries of the County Manager, Deputy County Manager and the following Department Heads shall be as hereinafter set forth. The same shall be effective as of July 1, 2008 or as of appointment date and remain in effect thru December 31, 2009.

Section 3. That this Ordinance shall take effect at the time and manner provided by law.

Section 4. That the Clerk of this Board be and she is hereby authorized to publish a notice in the appropriate newspaper of such introduction and of a public hearing on December 18, 2008, and shall forward one certified copy of final passage, to each Clerk of all Municipalities located within the County of Union.
