AN ORDINANCE CREATING THE UNION COUNTY  
IMPROVEMENT AUTHORITY PURSUANT TO THE  
PROVISIONS OF N.J.S.A. 40:37A-44, et seq.

BE IT ORDAINED by the Board of Chosen Freeholders of the County of Union as follows:

Section 1. The County Improvement Authorities Law, constituting Chapter 183 of the Laws of 1960 of the State of New Jersey, as amended (N.J.S.A. 40:37A-44 et seq.) (the "Act") provides for the creation of a improvement authority.

Section 2. The purposes of such an improvement authority as set forth in N.J.S.A. 40:37A-54 include the low cost financing of capital structures and facilities within the County of Union through the establishment of a pooled governmental loan program.

Section 3. The Board of Chosen Freeholders has determined the creation of an improvement authority is in the best interest of the citizen of Union County.

Section 4. There is hereby created a public body corporate and politic, pursuant to the Act under the name of the Union County Improvement Authority (the "Authority").

Section 5. The Authority shall consist of five (5) members who shall be residents of Union County to be appointed by the Union County Board of Chosen Freeholders.


Section 6. Certified copies of this Ordinance shall be filed forthwith by the Clerk of the Board of Chosen Freeholders in the Office of the Secretary of State and in the Office of the Division of Local Government Services, in the Department of Community Affairs.


Section 7. This Ordinance shall take effect at the time and in the manner provided by law.
